#### **Product Description**

PP 513MN40 is a controlled rheology PP grade of medium molecular weight distribution. It contains an antistatic agent and is specially developed for producing injection molded articles. This grade has a good impact resistance (even at low temperature) and good stiffness.

# **Processing Conditions**

Barrel temperature range: 200 - 225°C.

Mold Shrinkage: 1.2 - 2.5% depending on wall thickness and processing conditions.

Mold Temperature: Normally 15 - 40°C, up to 65°C for thick parts.
